Important Tax Notice: *The full \$445 three-in-one total membership dues paid to the Wilkes - Yadkin HBA (\$182 to National, \$70 to State) are not fully deductible as a charitable contribution for federal income tax purposes. However, they may be deductible as ordinary and necessary business expenses... subject to restrictions imposed as a result of association lobbying activities. The NCHBA estimates that the non-deductible portion of your 2016 dues – the portion which is allocable to lobbying – is 44%. For a member who pays their regular NCHBA dues of \$70 in 2016, 44% or \$30.80 will not be eligible for deduction as a business expense, and \$39.20 may be tax deductible. The National Association of Home Builders has made a similar calculation. NAHB has determined that 15% of its \$182 dues is non-deductible. Thus, \$27.30 is not deductible and \$154.70 may be deductible.*
